Sealed bid proposals will be received via courier to the Alabama State Port Authority, 1400 Alabama State Docks Blvd., Room 216, Administration Building, Mobile, AL 36602 by 1:30 P.M., on Tuesday, July 24, 2018. Sealed bid proposals can also be hand delivered from 1:45 P.M. to 2:00 P.M., on Tuesday, July 24, 2018 to the Alabama State Port Authority in the International Trade Center Building, 250 North Water Street, 1st floor – Killian Room, Mobile, AL. Faxed or electronic submitted bids will not be accepted.

The work consists principally of providing bonds, labor, materials, equipment, and supervision necessary for the construction of a new container handling storage yard inclusive of all required removal work, fill work, soil improvements, grading and RCC paving work, utilities, electrical distribution, lighting and fencing requirements.

Complete Plans and Specification sets will be furnished to qualified prospective bidders upon payment to Aptim Port Services, LLC of One Hundred Fifty (\$150.00) Dollars (check or money order only) per set, none of which will be refunded.

A Pre-Bid Meeting is scheduled for Tuesday, July 10, 2018 at 9:00 A.M. in the international Trade Center Building, 250 North Water Street, 1 st floor – Killian Room, Mobile, AL.

A Guarantee will be required with each bid as follows: At least five (5%) percent of the amount bid, but in no event more than Ten Thousand (\$10,000) Dollars, shall be furnished in the form of a certified check or bid bond payable to the Alabama State Port Authority.

Performance and Payment bonds will be required at the signing of the contract in an amount not less than One Hundred (100%) percent of the contract price.

No bid will be considered unless the bidder, whether resident or non-resident of Alabama, is properly qualified to submit a proposal for this work in accordance with all applicable laws of the State of Alabama. This shall include evidence of holding a current license as required from the State Licensing Board for General Contractors, Montgomery, Alabama with the classification being appropriate for this type of work. In addition, non-residents of the State must show evidence of having qualified with the Secretary of State to do business in AL.

Bids will be publicly opened at 2:00 P.M., Tuesday, July 24, 2018 in the International Trade Center Building, 250 North Water Street, first floor – Killian Room, Mobile, AL. The right is reserved, as the interest of the Alabama State Port Authority may require, to reject any and all bids and to waive informalities in bids received.
