SP-13 GUARANTEE (WARRANTY)

The Contractor shall furnish to the Alabama State Port Authority a Minimum Ten (10) Year Written Guarantee, except where specified elsewhere, issued starting from the date of Final Acceptance.

This Guarantee shall cover any defective materials or workmanship on the entire project including LED Luminaires and Components.

All costs shall be included in the Proposal's Costs.

Manufacturers' Warranties shall name ASPA as Owner and be included in Close Out Documentation.
