Sealed bid proposals will be received via courier to the Alabama State Port Authority, 1400 Alabama State Docks Blvd, Room 216, Administration Building, Mobile, AL 36602 by 1:00pm, on Wednesday, January 11, 2012. Sealed bid proposals can also be hand delivered until 2:00pm, on Wednesday, January 11, 2012 to the Alabama State Port Authority in the International Trade Center building, 250 North Water Street, 1st floor – Killian Room, Mobile, AL. Faxed or electronic submitted bids will not be accepted.

MCDUFFIE TERMINAL – DOCK 1 RAIL EXTENSION MOBILE, ALABAMA

The work consists principally of providing bonds, labor, materials, equipment, and supervision necessary for the modifications required to the existing Dock 1 for the operation of a new shiploader inclusive of all required demolition work, concrete piling installation work, concrete work, concrete bridge section installations, crane rail installations and other required crane interface modifications all as indicated in the contract drawings and specifications.

A Pre-Bid Meeting is scheduled for Tuesday, December 20, 2011 at the Killian Room, located on the 1st Floor of the International Trade Center, 250 North Water Street, Mobile, Alabama at 9:00am local time. Bidder attendance is optional.

A Guarantee will be required with each bid as follows: At least five (5%) percent of the amount bid, but in no event more than Ten Thousand (\$10,000) Dollars, shall be furnished in the form of a certified check or bid bond payable to the Alabama State Port Authority.

A Performance Bond in an amount not less than the sum bid will be required at the signing of the contract and, in addition, a bond in an amount not less than One Hundred (100%) percent of the contract price, insuring payment of all labor and material.

No bid will be considered unless the bidder, whether resident or non-resident of Alabama, is properly qualified to submit a proposal for this work in accordance with all applicable laws of the State of Alabama. This shall include evidence of holding a current license as required from the State Licensing Board for General Contractors, Montgomery, Alabama. Also, non-residents of the State must show evidence of having qualified with the Secretary of State to do business in AL.
